It is critical for all law-abiding citizens to understand the current California Firearms Law and establish a clear understanding of the importance and practice of firearms safety. This course will cover Firearms Safety for Handguns, Rifles and Shotguns including safe storage and owner responsibilities. The skills learned in this course, when established early, will greatly reduce the risk of accidents and injuries. Other topics include Home Defense/Self Defense laws, CCW info, planning and practices, understanding firearms and ammunition. As an added bonus, Surviving Workplace/School violence, unarmed response tips and situational awareness will be discussed.

Effective January 1, 2015 a Firearm Safety Certificate is required to purchase or receive any Rifle, Pistol, or Shotgun in the State of California. Upon completion of this course, each paid attendee will receive the require certificate. Registered students may bring a non-registered family member or guest, to monitor the class, without receiving a certificate, at NO CHARGE.
